

## Wagler Kennels Puppy Guarantee

1. The puppy leaving today is in good health to the best of our knowledge and has been examined by a licensed Veterinarian.
2. In order for our guarantee to take affect, we require the puppy to be taken to the customers vet of choice within 5 business days.
3. In the unlikely event your vet finds something wrong, we require a signed vet paper stating the diagnosis and the cost of the examination. We will not reimburse for any vet treatment we do not approve first. At first visit, vet needs to do a spool specimen and check for Coccidia, which is a prevalent thing in puppy litters. When treated, it's a very minor thing. If positive, we will reimburse up to \$50. for a 3 day treatment. Please call us with any problems.  
**BE ADVISED! SOMETIMES VETS CAN TAKE ADVANTAGE OF NEW PUPPY CUSTOMERS AND REQUIRE THEM TO REDO OR START OVER IN IMMUNIZATIONS, OR SUGGEST/PUSH OTHER TREATMENTS. OUR PUPPIES HAVE BEEN VET CHECKED AND ARE UTD AS WE SAY. YOU CAN REFUSE TREATMENT OF A VET WHO TRIES TO REQUIRE YOU TO DO THINGS WE'VE ALREADY DONE.** We have had over 25 years' experience in raising dogs so we trust you can rest assured we care deeply for our dogs and do all we can to insure their health before they leave for their new homes.
4. The breeder cannot assume responsibility of the pet after it leaves us. It is the responsibility of the buyer to care for the puppy properly and keep it free from harm. Please remember that your puppy must be treated with great care and protected from danger.
5. Our guarantee does not include minor illnesses and health issues such as colds, allergies, internal or external parasites or umbilical hernias. However, the breeder will disclose any known illnesses or health issues prior to the sale. We also do not cover neutering or spading.
6. We cover any genetic diseases that may come upon the puppy within 6 months or injury that can be traced back to our kennel.

7. We will either pay for the cost of the vet up to the cost of the original purchase price of the puppy or we will replace the puppy if the puppy has been proven to have a genetic issue or sickness from our kennel. We will not pay anything above the original cost of what the buyer has paid us.

8. We do not cover any kind of injury or sickness due to you or your families lack of care or gross negligence.

9. You are required to give this puppy the proper amount of food, water, shelter, exercise, and routine visits to the vet to ensure the puppy is in the best health possible.

10. We do not cover routine worming costs or vaccinations.

11. We will take the puppy back at anytime at no cost if you decide you no longer can take care of the puppy/dog. If for some reason you decide you cannot keep the puppy, we will take him/her back. However, we cannot refund the money.

12. We cannot guarantee size, weights, color, or personality. We will do our best to give an educated guess but there are too many variables that can change.

13. We reserve the right to change adoption fees from litter to litter and depending on color, time of year, and demand.

14. This is a pet limited AKC registration contract only. We can revoke the limited to full if you decide to purchase at a future date. Buying today is \$1,000 extra, future will be \$1,200.
